## About University:

Annamalai University is one of the largest unitary, teaching and residential Universities in Southern Asia comprising of 10 Faculties and 49 departments of study. In the Pharmacy Category the ranking is 12th in India and in the Medical category the ranking is 25th in India. "The Times Higher Education World University Ranking - 2019" has ranked University in 1000+ for Overall category. In the Subject category Ranking, 2019, the University is ranked in the band of 501-600 for Life Sciences and Pre-clinical, clinical & Health Subjects. 800+ in the Physical Sciences subject. "The QS World University Ranking - 2019" has ranked University in the band of 291 - 300 in Asia Ranking, 174 in the BRICS Ranking and 43 in India Ranking. "The CWTS Leiden Ranking 2018", on scientific impact of universities and on universities' involvement in scientific collaboration & scientific performance, has ranked the University at 20th based on the number of publications and 4th based on the proportion of publications that, compared with other publications in the same field and in the same year, belong to the top 10% most frequently cited.

"The MDRA - India T oday Ranking" (2018) has ranked Annamalai University 13th among the best Government Universities in India. "The SCImago Institutional Ranking" (2018) has ranked 7th in Tamil Nadu and 32nd among the top 197 ranked institutions for Higher Education in India.


