## NOTICE ON RAGGING

### RAJAH MUTHIAH DENTAL COLLEGE AND HOSPITAL

#### CURBING THE MENACE OF RAGGING IN EDUCATIONAL INSTITUTIONS

**1. Definition: Ragging is defined by the H'ble Supreme Court of India.**

“ Any disorderly conduct whether by words spoken or written by an act which has the effect of teasing, treating or handling with rudeness to any other student, indulging in rowdy or undisciplined activities which causes are likely to cause annoyance, hardship, psychological harm or to raise fear or apprehension here of on a fresher or a junior student and asking the student to do any act or perform something which such student will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely effect the physique or psyche of a fresher or junior student”.

**2. Ragging in any form is strictly banned in the premises of Rajah Muthiah Dental College and Hospital, Boys Hostel, Girls Hostel and Annamalai University campus as a whole. Any incident of Ragging will be immediately reported to the Authorities and action taken against the perpetrator of Ragging.**

**3. Any student indulging in Ragging will be dealt with appropriately in one or more of the following ways:**

- a) FIR will be lodged against those involved in ragging.
  - b) Suspension/expulsion from hostels
  - c) Suspension/expulsion from college
  - d) Cancellation of admission
  - e) Debarring from representation in any events of the college
  - f) Debarring from appearing in examination /any evaluation process.
  - g) Withholding of scholarships
  - h) Rustification from the college up to 2 years of study.
  - i) Fine of Rs. 25,000 to Rs. 1,00,000/-
4. The burden of proof of ragging shall lie on the perpetrator of the ragging and not on the victim.
  5. An offence of ragging may be charged either on a written complaint by the affected party or any individual who is a witness to the ragging.
  6. Strict action as enunciated above in para 3 will be taken against those found guilty of ragging and those abetting ragging.
  7. Freshers who do not report the incidents of ragging either as victims or as witness shall also be punished suitably.
  8. Report any incident of ragging to any of the following numbers.

# **ANTI RAGGING MEASURES**

## Anti Ragging Measures

Administrative action in the event of ragging:-

The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed here in under:

- a) The anti-ragging committee of the institute shall take an appropriate decision in regard to punishment or otherwise depending on the facts of each incident of ragging and nature and gravity of the incident of the ragging established in the recommendations of the Anti-ragging squad.
- b) The Anti-ragging committee may depending on nature and gravity of the guilt established by the anti-ragging squad , award, to those found guilty, one or more of the following punishments, namely:
  - I. Suspension from attending classes and academic privileges
  - II. Withholding/withdrawing scholarship/fellowship and other benefits.
  - III. Debarring from appearing in any test/examinations or other evaluation process.
  - IV. Withholding results.
  - V. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
  - VI. Suspension /expulsion from the hostel.
  - VII. Cancellation of admission.
  - VIII. Rustification from the institution and consequent debarring from admission to any other institution for a specified period.
  - IX. Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.
- c) An appeal against order of punishment by the anti-ragging committee shall lie.
  - I. In case of an order of an institution, affiliated to or constituent part, of a University, to the Vice-Chancellor of the University.
  - II. In case of an order of a University , to its Chancellor.
  - III. In case of an institution of national importance created by an act of parliament , to the Chairman or Chancellor of the institution, as the case may be.
