Quality issues are often common and no one takes the responsibilities of poor or substandard medicines in the market. The Government of India has recently notified that the Marketing Company is responsible for quality issues of the medicines they market. This is a welcome move ensuring quality medicines in the market.

COVID - 19, though surfaced first at Wuhan City of China, removed all manmade barriers affecting the health of millions worldwide. India has initiated a war against this scary novel corona virus with Janata Curfew (Peoples Curfew) to suspending public transport services including complete lockdown in many areas in an attempt to break the transmission chain of the virus. Perhaps, in recent history such level of public health issue has not been seen. In addition to public health scare, the corona virus has threatened medicine security system. While India has been known as the 'Pharmacy of the World', in absence

of supply of Active Pharmaceutical Ingredients (APIs) from China, it becomes difficult for the country to have sustainable supply for even domestic need. As a precautionary measure, the Government of India has already restricted the export of 13 APIs and their formulations. As there have been complete shutdown of API industries in China, India is in very vulnerable position as about 70% of APIs are from China alone. India is strong in finished good production but not on raw materials. Now, the Corona has taught us the need of self-sustainability and a package of Rs 13,760 crore for incentivising production of raw materials and APIs. This stimulus package could have been given much before. But better late than never!

Our honourable Prime Minister has given a call for recognising the services of health workers, essential service providers, and security persons who have been working tirelessly risking their life during our war against COVID-19. We salute them!

Wishing you all Safe and Healthy during this unprecedented health crisis!

TrueNat Assay Kit: TrueNat TB test is developed by Indian Scientists intended to detect tuberculosis and multi-drug resistant TB. It has high diagnostic accuracy and World Health Organization has already endorsed. It provides result in about 90 minutes.

Two New Antibiotics Approved in India: Two new antibiotics discovered and manufactured by Wockhardt are approved by Drugs Controller General India. These novel antibiotics: EMROK (IV) and EMROK (Oral) indicated for acute bacterial skin and skin structure infections including diabetic foot infections and concurrent bacteraemia.

All Medical Devices are brought under Drugs and Cosmetics Act: The Government has notified the Amendment of Medical Device Rules bringing all medical devices under regulatory control. All medical devices including an instrument, apparatus, appliance, implant, material or other article, whether used alone or in combination including a software are now regulated

as drugs. The new rule is effective from 01st April 2020. This would help the government to exert control for ensuring their quality and bringing them under price control mechanism.

Restricted use of anti-HIV drugs for nCorona virus approved: The Drugs Controller General of India has approved the combination of lopinavir and ritonavir for patients with novel corona virus infection. These drugs are already approved for HIV treatment. The restricted use approval is an emergency measure in case of a public health emergency on patients affected by nCoV as per the treatment protocol designed by the ICMR. "Before using this combo of drugs on any patient, the doctor has to take an informed consent from the patient.

Indigenous Glucometer Developed: India has developed "SuChek", a diabetes test kit. This indigenously developed glucometer is suitable for diverse climatic conditions and affordable, Government announced.

Clinical Management of severe acute respiratory infection when COVID – 19 is suspected: The World Health Organization (WHO) has released interim guideline for clinicians taking care of hospitalised adult and paediatric patients with severe acute respiratory infection (SARI) when a nCoV infection is suspected. It is not meant to replace clinical judgment or specialist consultation but rather to strengthen clinical management of these patients and provide to up-to-date guidance. 'Self-Care' for sexual and reproductive health: The World Health Organization has published this guideline focusing on ways people can look after their own sexual & reproductive health, including self-injectable contraceptives, home-based ovulation predictor kits, HIV self-testing and self-sampling for HPV and sexually transmitted infections. Where There Are No Pharmacists: Where there are no trained pharmacists serving communities, other categories of health workers are called upon to order, buy, store, dispense and advise people on rational use of medicines. Where There Are No Pharmacists explains how to order them, store them, prepare them, dispense them and use them safely and effectively. National Guidelines for Gene Therapy Product Development and Clinical Trials: The Council of Medical Research (ICMR) along with the Department of Biotechnology (DBT) has released the National Guideline for Gene Therapy Product Development and Clinical Trials. This guideline outlines the ethical and scientific requirements for gene therapy trials keeping in mind patient safety and efficacy. USFDA Strengthened warning on Clozapine: The USFDA warned that constipation caused by the schizophrenia medicine, Clozapine, may lead to serious bowel complications. This can lead to hospitalization or even death if constipation is not diagnosed and treated quickly. The healthcare professionals are advised to evaluate bowel function before starting a patient on clozapine and avoid co-prescribing clozapine with other anticholinergic medicines that can cause gastrointestinal hypomotility. The patients are also advised to contact their doctor if any of these signs appear: nausea, vomiting, bloating or belly swelling, or belly pain.

Lamotrigine with possible immune system reaction: The Central Drugs Standard Control Organization (CDSCO) in a safety alert communication asked all State Drugs Control Authorities to inform companies manufacturing Lamotrigine to insert warnings about 'hemophagocytic lymphohistiocytosis (HLH)' reaction as part of their leaflets or packaging inserts. Lamotrigine, a widely-sold medicine to treat bipolar disorder and seizures in epileptic patients will now have to carry a side-effect warning of possible 'immune system reaction' on its packages.

Nimesulide associated with Stevens-Johnson Syndrome (SJS) / Toxic Epidermal Necrolysis (TEN): The Pharmacovigilance Programme of India (PvPI) had issued advisory for the rational use of nimesulide following a case of nimesulide induced Stevens - Johnson Syndrome. In spite of the drug banned from using in paediatric population, it was inappropriately prescribed in child who developed the above adverse reaction. PvPI has urged healthcare professionals to take all necessary precautions in order to avoid such mis-happenings.

- 1. Extra salt, Salt shaker on dining table, Pickle, Papad, Canned foods, Preserved food, Sauces, Jams, Jellies, Ketchup, Instant soups, Soup cubes, Packaged foods;
- 2. Salted nuts, chips, bread, and popcorn etc;
- 3. Bakery products such as biscuits, cookies, bread, cakes, donuts, waffles, puffs, khari etc, fried snacks and savouries;
- 4. Smoked, processed or canned meats, pork, beef, red meat, egg yolk, salted and dried fish;
- 5. Margarine, vanaspati and butter; and
- 6. Avoid reheating and reusing oil.



1	Cidofovir dihydrate bulk drug and Cidofovir injection 75 mg/ ml (5 ml single use vial)	Cidofovir is indicated for the treatment of CMV retinitis in adults with acquired immune deficiency syndrome (AIDS) and without renal dysfunction. It should be used only when other medicinal products are considered as unsuitable.	03.01.2020
2	Dacomitinib tablet 15mg, 30mg and 45mg	For the first line treatment of patients with metastatic non-small cell lung cancer (NSCLC) with epidermal growth factor receptor (EGFR) exon 19 deletion or exon 21 L858R substitution mutations.	03.01.2020
3	Alpelisib film coated tablets 50mg, 150mg, 200mg	Alpelisib is a kinase inhibitor indicated in combination with Fulvestrant for the treatment of postmenopausal women, and men, with Hormone receptor (HR)-positive, human epidermal growth factor receptor 2 (HER2)-negative, PIK3CA-mutated, advanced or metastatic breast cancer following progression on or after an endocrine-based regimen.	03.01.2020
4	Isavuconazole sulfate 100mg capsules	Indicated for patients 18 years of age and older for the treatment of Invasive Aspergillosis and Invasive Mucormycosis	14.02.2020

Corona Virus Disease (COVID - 19)

COVID – 19, novel corona virus disease, has been scaring all of us for last three months or so. The causative virus is named as: severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2). Though originated in Wuhan City of China has so far affected the people of 197 countries including India. It has killed 18,589 persons globally (as of 26th March 2020). The World Health Organization has confirmed that COVID – 19 is pandemic in nature. The Government of India has called for complete shutdown of the entire country for three weeks to break the chain of transmission.

However, Lopinavir/Ritonavir, a fixed dose combination antiretroviral sold under the brand name of Kaletra, has been approved by the Central Drugs Standard Control Organization (CDSCO), for restricted public health use among the symptomatic Covid-19 patients,

The Government of India has also recommended the use of Hydroxychloroquine (HCQ) for high risk population - asymptomatic healthcare workers involved in the care of suspected or confirmed cases of COVID-19 and asymptomatic household contacts of laboratory confirmed cases.


